Instructions: After you receive a nuisance call, hang up, and immediately pick up the receiver. Listen for a dial tone and then press *57. You will hear an announcement stating whether the call was able to be traced or not. If the call is traceable, call your local law enforcement agency and report the information to have a case opened. After a case number has been assigned, call Norvado (715-798-3000) and they will follow the appropriate steps to have the call traced. Once this process is complete, the proper authorities will contact you in regards to the information collected. COT works in conjunction with Caller ID service to identify phone numbers. If Caller ID shows anything other than a phone number (i.e. private, non-pub, fictitious number, etc.), the call will not be traced.

Instructions: After you receive a nuisance call, hang up and then immediately write down the date and time of the call. Contact your local law enforcement agency and report the information to have a case opened. After a case number has been assigned, call Norvado (715-798-3000) and they will release the information to the appropriate law enforcement agencies. This service expires after thirty (30) days. This service captures the originating telephone number and/or carrier. CLI does NOT rely on Caller ID service.
